#### MINUTES OF THE BUCKSKIN FIRE DEPARTMENT DISTRICT FIRE BOARD

09/12/18-Open Meeting: Minutes to be approved at open public meeting on Wednesday, October 10, 2018. An Open Meeting of the Buckskin Fire Board convened on September 12, 2018 at 6:00 pm in the classroom of Station 1 of the Buckskin Fire Department located at 8500 Riverside Drive, Parker, AZ 85344. The following matters were discussed at the Open Meeting.

- 1. Call to Order: 6:01 pm
- 2. Roll Call.

Members Present: Chairman Jeff Daniel, Bob Gory, board member Don Rountree, called in at time of meeting. Secretary/Clerk: Wayne Posey arrived while meeting in progress, at 6:03. Glenda Gerson absent

Staff Present: Chief Maloney, Barbara Madison. Public Present: No public present.

3. Possible motion to go into Executive Session pursuant to A.R.S. §38-431.03.A.3 and/or A.R.S. §38-431.03.A.4 consultation for legal advice.

Chairman Daniel read the Agenda Item, and asked Chief Maloney for comment or brief introduction of the topic. Chief referred to his summary report included in the Agenda Packet, and stated that the report had been sent to Attorney Whittington; to which Mr. Whittington had previously replied (via email) that he reviewed the summary and found no errors in it or the recommendation. Mr. Rountree stated [via telephone] that he did not see a need for further discussion. As Mr. Posey joined the meeting already in session, he asked to comment.

Chairman Daniel yielded the floor, and Mr. Posey shared his concern of former Chief Chamber's stated earnings to be considered for application into the DROP APSPRS Retirement program. He detailed the events that had transpired during the BFD Local Pension Board meeting, and questioned the accuracy or legitimacy of the reported earnings; stating that the excess income was a result for back coverage [for Wildland station coverage]. His concern of overstating earnings prompted Mr. Posey to direct the BFD Staff to conduct an internal investigation.

Chief Maloney interjected that if the discussion was to continue, we needed to go into Executive Session. Mr. Posey continued his discussion and stated that the prior resolution that former Chief Chambers had previously brought forward indicated that he [Chief Chambers] was authorized to earn pay 1 ½ times the hourly rate of Senior Captains' rate, when working outside of the District; he concluded that Station Coverage was not outside of the district, but at the fire station.

Admin Assist. Madison reminded the Board Members that the Agenda is written in a manner to protect the Fire Board, and that they needed to adhere to the Agenda. The ensuing discussion was not on the Agenda, and by discussing the matter outside of an Executive Session opened it up to the public meeting. Chairman Daniel again asked if the Board wanted to make a motion to go in to Executive Session to seek legal counsel. Mr. Posey continued to share his concerns, and replied that the topic had already been discussed at a public meeting.

Chairman Daniel asked Mr. Rountree if he wanted to discuss it any further, to which he replied, "No." He further suggested an Executive Session be scheduled at the next meeting for legal advice.

4. (Discussion and Possible Action): Possible directive for Chief Maloney relating to consultation with attorney for legal advice. No action; as Executive Session had not convened.

- 5. (Discussion and Possible Action): La Paz County Assessment update. Chief Maloney reported that County Assessor Anna Camacho met with him and told him that the Assessor's Office had made a mistake on the Personal Property Taxes and overstated the abstract values by \$16,711.39. He referred to the supporting documentation that had been provided in the Agenda Packet, and surmised that BFD had to options:
  - i. Receive \$16,711.39 less in tax revenue -or
  - ii. Amend tax rate to a higher rate of 3.0486.

His recommendation to the Board was to receive less revenue and if needed use part of the contingency fund to meet expenses that occur.

Motion made be Wayne Posey, seconded by Bob Gory to receive the lessor amount of tax revenue, and if needed any additional amount to be taken out of contingency with Fire Board approval.

There were no further comments or questions prior to voting

6. (Action Item): Approval of Minutes submitted for the Open Meetings held on 08/08/18. Motion made by Wayne Posey for the approval of Minutes for the meeting of 08/08/18, along with a second from Bob Gory. There were no comments or questions prior to voting Ayes: Daniel, Posey, Rountree & Gory Nayes: Absent: Gerson Abstain: Chairman Daniel: Motion passed by a majority vote on agenda item #6.

- 7. (Discussion and Possible Action:) Due to the issues that the County Assessor's office had, the County was unable to get us the financial reporting necessary to balance our accounts, we will have August and September financials on next month's agenda. *No Action taken.*
- 8. Old Business (Discussion and Possible Action) re; tabled action from previous meeting, to be tabled until further notice from board, but to remain on any future agenda until action taken or permanently removed.
- A. RFQ Legal; requested by Board Member Bob Gory. No motion for this item, keep as a tabled discussion until discussions with Attorney regarding the current issue is resolved. This item will appear on each agenda as a place hold until an action from the board takes place.

- 9. (Discussion and Possible Action): Regarding Policy Manual and Draft Policies.
  - SAP's written by legal counsel in 2016; 2nd reading
  - Placeholder for Additional Policies for introduction/first reading only.

Chairman referred to Chief Maloney. Chief Maloney reported that he had not received any comments regarding changes or recommendations from the Board Members. He added that the staff had been working on compiling the Policies in one cohesive manual.

Motion made by Bob Gory to accept the draft policy as presented in the 2<sup>nd</sup> reading, along with a second from Don Rountree. There were no further comments or questions prior to voting Ayes: Daniel, Posey, Rountree & Gory Nayes: Absent: Gerson Abstain: Chairman Daniel: Motion passed by a majority vote on agenda item #9.

The Fire District Board cannot discuss or take legal action on any issue raised during the Call to the Public that is not on the current Agenda; due to restrictions of the Open Meeting Law. No Public Present.

### Chief's Monthly Report -September

Troy Maloney, Fire Chief

As this is written on Wednesday, October 10<sup>th</sup>, additional updates will be provided at the next Board meeting.

<u>Personnel</u>: Five of our personnel attended the 2018 State of Arizona Fire School program held in Mesa, Arizona. This was a three-day statewide training event. Through one of the multi-day courses offered, Lieutenant Fernandes became a State of Arizona certified Fire Inspector-I.

Firefighter Brandon Quinn on successfully completing his Paramedic program and passing the National Registry of Emergency Medical Technicians test for Paramedic.

With the addition of FF Quinn becoming a Paramedic, effective November 8<sup>th</sup>, both stations on all three shifts with have advanced life support medics assigned to the engines.

On Oct 10<sup>th</sup>, our crew at station 11 taught fire extinguisher operations to three classes of La Paz County employees.

<u>Apparatus</u>: 1151 has been put back in service as a front-line response vehicle at station 11. This vehicle was designed and built to respond to incidents in remote areas where a smaller 4x4 vehicle is required; like the Desert Bar area. 1151 is also equipped to respond to technical rescue calls.

1152 is being utilized by the fire chief as a command vehicle until a proper vehicle is purchased to replace it.

Boat-1 was is using an older/used lower outdrive unit while repairs are being made to the regular one. The cost of the repairs is \$4400.

1102 is back at Freightliner for more warranty work.

<u>Facilities:</u> We continue to find more and more need for repairs and maintenance to our buildings and grounds that were not budgeted for in FY 18/19.

Station 11 is having moisture issues from water damaged and we are having AmeriSpec Home/Commercial Inspection Service to perform an evaluation of station 11. The estimate from a commercial contractor to repair/replace the roof is \$30,000.

<u>Incidents</u>: Sept 5<sup>th</sup>, Boat-1 was assisted the La Paz County Sheriff (LPSO) office with a recovery of a stolen water craft due to LPSO not having a boat operator available and this being a time sensitive event. The LPSO is very aware of the amount of assistance that BFD Boat-1 provides to the community.

Sept 10<sup>th</sup>, E-1101 and 1100 performed a stand-by at the Emerald Canyon Golf Course while the County performed a large-scale controlled burn. E-1101 and 1100 remained available to responded to emergent incidents.

Sept. 16<sup>th</sup>, Boat one responded to a boat that flipped over in front of station 11 with one person ejected from the boat. No injuries were found and the boat was recovered by another boater before it sank.

Sept. 18<sup>th</sup>, Engine 1102 was deployed to the Pole Canyon Fire in Utah with Weatherford as the Engine Boss, Kowalski as the Engine Boss Trainee and Honomichl as the Firefighter.

Sept. 19<sup>th</sup>, Tactical Tender 1132 was deployed to the Roosevelt Fire in Wyoming with Foerstner as the Engine Boss and Maxwell as the Firefighter.

Sept 29<sup>th</sup> at 12:30 PM, Boat-1 responded to a stranded boat with two occupants. Boat-1 took the occupants to the shore.

Sept 29<sup>th</sup> at 8:00 PM, Boat-1 and 1102 responded to a watercraft accident a ½ mile south of the dam. Boat-1 arrived to find one patient with a leg injury.

Sept 30<sup>th</sup> at 3:330 PM, 1102 responded to a powerline down on Rio Way. 1102 arrived to find a power pole on fire.

Oct. 2<sup>nd</sup> at 2:30 PM, 1151 with POC Anderson and FF Quinn responded to CRIT to dive on a vehicle in the canal. No victims were found and a stolen vehicle was recovered.

Oct 3<sup>rd</sup> at 7:00 PM, 1100, 1101 and 1102 respond to the area of Pirates Den for a swift water rescue from a flash flood on Riverside Drive. 1101 and 1100 arrived to find a car stuck in the middle of flood waters with one occupant who had self-rescued and was not injured.

<u>Finances:</u> La Paz County Assessor's Office that they had made a clerical error when assessing the 2018 Personal Property Taxes which overstated the abstract values by \$16,711.39. Our current tax rate was set a 3.0215 which would levy \$1,865,371.00 in property taxes for the Buckskin Fire District. With the corrected values applied, we would need to amend our current FY18/19 budget to reflect a tax rate of 3.0486 to levy the same amount of \$1,865,371.00. The Board has two choices; amend the that rate to 3.0486 to meet our FY 18/19 budget or leave the current tax rate at 3.0215 and levy \$16,711.39 less than budgeted for.

County Supervisor Minor has been assisting us with trying to find funding, but has not had any luck. I have spoken with the La Paz County Finance Director Terry Krukermyer who confirmed the La Paz County receives over \$2,000,000 from Payment In-Lue of Taxes (PILT) funds from the Bureau of Land Management (BLM) for "firefighting & police protection and search & rescue operations", but the County does not foresee the sharing of those revenues with the fire districts. According to the Arizona Fire Districts Association, none of the counties in Arizona share the PILT funds they receive.

<u>Administration</u>: We hosted a Parker regional Chamber of Commerce Mixer on September 20th from 5pm to 7pm. The event was attended by approximately 40 members.

We are working on creating a Capital Improvement Plan (CIP) Depreciation Funding Schedule for FY 2019/2020. This will add us in planning for needed capital expenditures in the future. The long-term plan is to put the District in the financial position to pay cash and not use credit for purchases, thus limiting debt.

We are evaluating the financial reports that you receive in your packet to create a format that is easier to decipher and is more transparent to the public.




