Chief's Monthly Report - October 2020

Troy Maloney, Fire Chief

<u>Personnel</u>: Station 22 personnel still struggle to respond to 911 calls for service in Parker. It appears to be a cultural issue from previous administrations that we are diligently working on improving. They are doing a great job when we have crews on duty at the station, but night and Wednesday calls are still a major problem.

Station 22 crews participated with the Town of Parker's Trunk or Treat program and did a great job. The Town of Parker Manager expressed her appreciation of PFD's involvements in the community.

All other personnel are doing well.

<u>Apparatus</u>: 2221 is out of service and in Phoenix for repairs. The new ladder parts are to ship on November 6th.

2251 and 2202 are listed for sale on Brindlee Mountain Fire Apparatus. We have accepted an offer on 2202 of \$11,500; we are awaiting payment and pick up.

2231 is out of service awaiting to go to Phoenix for major repairs. We will be sending it after we get 2221 back.

2250 is out of service and at Lane's Auto for worn out ball joint and tie rod ends and then an alignment.

2203 is out of service due to a starting issue. Quality Fleet Solutions from Goodyear will be here next week to work on it.

2252 is out of service for a non-starting issue. It was towed to Lane's Auto on Thursday.

1101 was out of service for a transmission problem. Crews were working out of 1103; 1101 is back in service.

1151 was at Lane's Auto getting new tie rod ends, alignment, tires, and full engine service.

Brush-11 is out of service. The truck had a catastrophic driveline failure while en-route to a wildfire assignment in Colorado. The truck was towed to a Vanguard Truck service in Flagstaff and 1100 drove to Flagstaff to pick up the crew and equipment. It is sounding like our insurance is going to cover most of the repairs. The estimate for repairs was \$16,700.

All other apparatus is in service.

<u>Facilities:</u> No major issues or repairs. Swamp Coolers in the bays at station 11 are rusted out and need replacing; getting quotes.

<u>Incidents:</u> Oct 1st, at 06:00 hours, Brush-11 deployed to a wildland fire assignment northwest of Ft. Collins, Colorado near Red Feather Lake. They will be assigned to the Cameron Peak Fire. The Cameron Peak Fire is currently 125,006 acres and 30% contained. There are 882 firefighters, 15 (20 person) Hot Shot crews, 52 engines and 11 helicopters assigned to this fire.

Oct 3rd at 11:43 hours, 1102 and 1101 responded to a RV fire on Parker Dam Rd near Hwy-95. 1102 arrived to find a well involved RV that had rolled across the street and into a building. The building was now on fire also. 1102 called for mutual aid from Parker for a water tender; 2231 responded. 1102 quickly extinguished the structure fire and continued to protect the structure until 1101 arrived; units extinguished the RV fire. 2231 arrived and supplied water. The RV was a total loss and the building sustained damage to the awnings and stucco. The cause of the fire was from the occupants of the RV pouring gas into the carburetor and the motor backfiring. Two people sustained second degree burns; one refused treatment and the other was transported to LPRH by AMR.

While 1102 and 1101 were still on the scene of this fire, BFD was dispatched to a UTV rollover with injuries Desert Bar Rd; 1101 requested mutual aid from Parker; 2201 responded. 2201 arrived to find a stable patient with an arm fracture. The patient was transported to LPRH by AMR.

Oct 5th at 19:37 hours, 1102 and 1100 responded to a UTV accident with injuries reported to be five mile west of the Emerald Cove Resort. 1102 tied in with 1100 and drove Bowmans Wash Rd out five miles and started searching the area with negative contact. SBCSO responded with their UTV and searching the area also. SBCSO received GPS coordinates from the caller's cell phone which ended up being 16 miles west. SBCSO continued up rugged trails to find the victims of a rolled over UTV; no injuries. 1100 drove back to the staging area to meet with AMR. SBCSO gave the victims a ride back to the staging area were 1102 went back in service and 1100 gave the victims a ride back to their RV in Emerald Cove Resort.

Oct 6th at 01:53 hours, 1101, 1102/1132, 1100, 2201 responded to a structure fire on Crystal Canyon Dr. 1100 arrived to find a fully involved RV with exposures to a house and shed; 1100 took command of the incident and confirmed with the house occupants that no one was in the trailer. 1101 arrived and attacked the fire with a water supply from 1132/1102. 2201 arrived and checked the exposure buildings; no fire found. The fire was extinguished with no damage to the other structures. The cause of the fire is undetermined and suspicious. LPCSO was on scene and took a report. No injuries were reported.

Oct 8th at 13:00 hours, 1102 deployed to the Encinos Fire in southeastern Arizona with Captain Weatherford as the Engine Boss. The 5,500 Encinos Fire started Tuesday night, October 6, roughly 11 miles northwest of Sasabe, within the Altar Valley. The fire continues to burn actively due to

dry fuels and its growth is being aided by windy conditions. The fire continues to push to the north/northeast with expected and continued growth following terrain and the wind to the west, northwest, north, and northwest. The western side of the fire has burned onto the Tohono O'odhan Nation. Firefighters are working toward a 100% suppression strategy that uses tactics where they will have the greatest opportunity for success, including using existing roads and natural features to assist with fire suppression efforts. Values at risk include, structures to the north of the fire, a ranch, grazing allotments, and numerous cultural and archeological sites.

Oct 9th at 11:58 hours, 1102 and SBCFD responded to a reported plane crash at Black Meadow Landing. 1102 arrived to find a plane had crashed landed onto a truck and up against a water storage tank; no injuries. SBCFD contacted the FAA; 1102 cleared.

Oct 9th at 17:02 hours, 1102, 1101/1131 and 1100 responded to a RV fire in Havasu Springs Resort. 1102 arrived to find a fully involved RV with exposure to two other RVs and a large tree. 1102 requested 2201. 1100 arrived and took command of the incident. 1101 attacked the fire and protected exposures until 1101/1131 arrived and assisted in extinguishment. 1131 supplied water and 2201 was canceled. The RV was a total loss, heavy damage to one of the exposures and minor damage to the other. The cause of the fire was undetermined, but not suspicious.

Oct 13th at 22:54 hours 1102 responded to a vehicle fire on Parker Dam Rd near Cable Car day use area. 1102 arrived to find a fully involved passenger car; 1102 extinguished the fire. No occupants were found, and the fire was determined to be suspicious. The scene was turned over to SBCSO.

Oct 19th at 02:30 hours, 1101 and 1102 responded mutual aid to CRIT for a roller over accident with an ejection on HWY-95 near Osborn wash. 1101 arrived to find a single vehicle rollover with one critical patient who had been ejected from the vehicle. 1101 took command of the incident and 1102 took patient care. The patient was transported by AMR to the LPRH helicopter pad for a flight to West Valley.

Oct 20th at 11:31 hours, Boat-1, 1100 and 1102 responded to a boating accident with injuries in front of Fox's Resort. 1100 arrived to find a single boat wedge deeply under a dock at the RV area with two patients trapped inside and three other patients already out of the Boat. 1100 took command of the incident. 1102 and Boat-1 arrived and took patient care. A medical helicopter was requested to stage at the LPRH landing zone. One patient was pronounced dead on scene, and one transported by ground to the LPRH LZ for flight to West Valley Hospital were that patient passed away prior to being loaded into the helicopter. Three other patients refused treatment/transport. LPCSD and State Fish & Game were on scene. The cause of the accident is under investigation.

Oct 22nd at 03:49 hours, 1101 and 1102 assisted LPCSO with the extraction of a body off a cliffside in the area of Crows Nest Dr. Crews used rope rescue equipment to repel down the cliffside and load a deceased body into a recue Stokes Basket and hoist up the hill. The incident is being investigated as a homicide and no further information is available.

Oct 25th at 15:22 hours, 1151 and 1102 responded to a rollover accident on Desert Bar Rd. 1151 arrived to find a single patient with a servere head injury from a rollover UTV. The patient had been restrained but was not wearing a helmet. The patient was transported to the LPRH landing pad for a helicopter transport to West Valley trauma center.

Oct 28th at 07:26 hours, station 22 was dispatched to a school bus accident with injuries at the intersection of Agency and Laguna; no response from station 22. 2200 responded from upriver and

arrived to find CRIT FD and AMR already on scene with care of one patient with minor injuries. 2200 was canceled upon arrival.

Oct 29th at 00:59 hours, 2201 (with only one person. No other PFD FFs responded), 2200 and 1101 responded to a large tire fire on Hopi in Parker with exposure to a RV. 2201 and 2200 arrive to find a 20'x30'x10' pile of automotive tire 75% involved in fire and no exposures. 2200 took command of the incident. 2201 and 1101 laid two supply lines form a hydrant to the fire and used the master stream on top of 1101 to extinguish the fire. 40,000 gallons of water and 20 gallons of foam where used. The cause of the fire is undetermined, but very suspicious. Parker PD was on scene and took a report.

Administration: Our condolences go out to the Gory family for their loss of Robert Gory.

We continue to receive poor ambulance transport response from AMR (River Medical) and I believe it's time we start discussing the possibility of running an Advanced Life Support (ALS) ambulance out of station 211 with the on-duty personnel we already employee. Our community would be much better served.

We have submitted paperwork for the PFD proposed annexation of the Parker South area.

We have drafted an IGA between PFD and the Town of Parker for a fire hydrant maintenance & identification program; it's under review of the Town. Once we get it back, it will go in front of the PFD Fire Board for consideration.

October 21st met with two State of Arizona Fire Marshals to conduct a fire inspection at Sako Oil Company in Parker. This site is an extreme fire hazard and mitigation of the facility is now being enforced by the State Fire Marshal's office out of Phoenix.

We are working with Ia Paz County Emergency Management to update the County's Emergency Operations Plan. This plan includes the areas served by PFD and BFD.
